Directions

The Itasca Country Club is located one block North of Irving Park Road, 5 miles West of Route 83, 1 mile East of old Route 53, also known as Rohlwing Road. The entrance is set back from the main road, so watch those directions.

From route 53 or 290 (combined), exit East onto Thorndale Road, and go to Arlington Heights Road. Turn right (south) on Arlington Heights Road and follow it as it curves, to the first stop sign, Walnut Street. Turn left (east) onto Walnut Street, and go two blocks to Orchard Street, and again turn left. Orchard Street runs directly into the club.

From Irving Park Road, turn north on Walnut Street, cross over the tracks, turn right at Orchard Street.
